1	As per amendments No. 4, Drawing No. RECTPCL/PIA/DRG/38, dimension of layout is not provided without that we are unable to find out the quantity of cable.	Preliminary Engineering for the purpose of tendering considering the statutory complinaces, guidelines, regulations and best industry practices is in the scope of bidder.  Detailed Engineering for the purpose of execution of project is in the scope of sucessful bidder.  Therefore, assessment of costing based on avilable data and considering the risk on above basis is in the scope of bidder.	
2	Distance from Transformer to gantry is not provided without that we are unable to calculate the hardware items.		
3	Without giving the dimensions of Layout firefighting pipe quantity cannot be find out.		
4	Layout drawing No. RECTPCL/PIA/DRG/38 is not clear as different dimensions which need to be provided in the layout drawing is not mentioned. (i.e. distance from 220 KV & 33KV gantry to power transformer, total length and width of proposed Sub-station etc.).		
5	As per BPS 3 I R 3.0 please provide standard drawing of foundation for equipment listed in subjected clause or give bifurcated quantity of excavation, reinforcement, concreting etc. for complete subjected job. As it is not possible for any vendor to avail that much designing during tendering stage.		
6	As per BPS 3, R3.0, Please arrange to send the foundation drawing of the equipment's.		
7	Please confirm the conductor detail for 220 kV and 33 kV is as per drawing No. RECTPCUPIA/DRG/35 and RECTPCL/PIA/DRG/37.		Confirmed.
8	Request RECTPCL to confirm conductor details for different bays is as per drawing No. RECTPCL/PIA/DRG/35 and RECTPCL/PIA/DRG/37.
